

On August 16, 2024, Oncor filed with the Public Utility Commission of Texas its Application of Oncor Electric Delivery Company LLC for Approval to Amend its Distribution Cost Recovery Factor ("Application") in PUC Docket No. 56963. In addition, as required by 16 Tex. Admin. Code § 25.243(c)(1)(A), Oncor filed the Application with its municipalities having original jurisdiction over Oncor's rates and provided notice of the Application to all other municipalities in its service area.

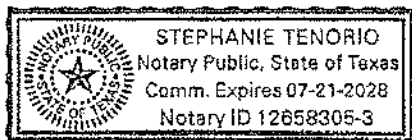

In particular, Oncor mailed a copy of the Application, including all attachments, via Federal Express, and also sent an email containing a link to the electronic native files, to all parties of record in PUC Docket No. 53601, *Application of Oncor Electric Delivery Company LLC for Authority to Change Rates*. The notice provided to the parties included the docket number for the new proceeding as required by 16 TAC § 25.243(e)(2).


On August 16, 2024, Oncor mailed notice to all authorized representatives for parties participating in Oncor's last DCRF proceeding. In particular, Oncor mailed a copy of the Application, including all attachments, via Federal Express and also sent an email containing a link to the electronic native files, to all parties of record in PUC Docket No. 56306, *Application of Oncor Electric Delivery Company LLC for Approval to Amend its Distribution Cost Recovery Factor*. The notice provided to the parties included the docket number for the new proceeding as required by 16 TAC § 25.243(e)(2).


