The Alliance of Oncor Cities ("AOC")¹ hereby files its Motion to Intervene in the abovenoted proceeding, and in support thereof shows as follows:

- 1. AOC is a coalition of municipalities located in the service territory of Oncor Electric Delivery Company, LLC ("Oncor"). AOC was formed to address the municipalities' concerns with, and interest in, utility rates, services, and operations. AOC and the residents and businesses located within the city limits of its constituent municipalities may be adversely impacted by the outcome of this proceeding.
- 2. AOC consists of regulatory authorities with standing to participate in this proceeding pursuant to the Public Utility Regulatory Act ("PURA"), Section 33.025, and the Commission's Procedural Rules 22.103(b) and 22.104.
