#### STEERING COMMITTEE OF CITIES SERVED BY ONCOR'S MOTION TO INTERVENE

COMES NOW, the Steering Committee of Cities Served by Oncor (OCSC) and files this Motion to Intervene in the above-styled proceeding. In support thereof, OCSC shows the following:

1. OCSC is a coalition of municipalities located within the service territory of Oncor Electric Delivery Company, LLC (Oncor). A list of the OCSC cities is included as Attachment A.

2. On August 16, 2024, Oncor filed an application for authority to amend its distribution cost recovery factor. OCSC, as well as its residents and businesses, may be adversely impacted by the relief requested by Oncor. Therefore, OCSC has a justiciable interest in this proceeding.

3. Additionally, OCSC has standing to participate in this proceeding pursuant to the Public Utility Regulatory Act (PURA) § 33.025.<sup>1</sup>
