COMMISSION STAFF’S REQUEST FOR REISSUANCE OF NOTICE AND REQUEST FOR EXTENSION

On August 23, 2024, Corix Utilities (Texas) Inc. (“Corix”) filed an application for a Name Change, and Amendment to Certificates of Convenience and Necessity, seeking to change the name on its tariffs and certificates held under CCN Nos. 21081 and 13277 to Utilities, Inc of Texas dba Corix Utilities (Texas) Inc.

On October 9, 2024, the administrative law judge (ALJ) filed order No. 3, requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on final disposition or file joint proposed findings of fact and conclusions of law by October 25, 2024.

I. REQUEST FOR REISSUANCE OF NOTICE AND REQUEST FOR EXTENSION

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Upon Staff’s review of the filings in this docket, Staff discovered an error in Corix’s and Staff’s pleadings, and in the notice published in the Texas Register on October 25, 2024. The the certificate of convenience and necessity (CCN) number for the listed CCN No. “13277” should be “13227”. Staff requests additional time for public notice to be given once more with the proper CCNs. Additionally, Staff maintains its request that the process used in Docket No. 53636 be followed in this docket, and that the Commission provide notice of this name change request to the Texas Register for publication. Therefore, Staff respectfully requests that the commission provide notice of this name change request to the Texas Register for publication, and extend the deadline to file a recommendation on final disposition until November 8, 2024.

II. CONCLUSION

Staff respectfully requests the entry of an order to consistent with the foregoing.
