**COMMISSION STAFF'S CLARIFICATION REGARDING NOTICE WITH THE  
TEXAS REGISTER AND REQUEST FOR ISSUANCE OF NOTICE**

On August 23, 2024, Corix Utilities (Texas) Inc. ("Corix") filed an application for a Name Change, and Amendment to Certificates of Convenience and Necessity, seeking to change the name on its tariffs and certificates held under CCN Nos. 21081 and 13277 to Utilities, Inc of Texas dba Corix Utilities (Texas) Inc.

On September 23, 2024, Staff filed a Recommendation on Administrative Completeness, Proposed Notice, and Proposed Procedural Schedule. In its filing, Staff recommended that if Corix's' Docket No. 54858 remains pending at the time of the final order approving the name change in Docket No. 56979, Corix be ordered to file a copy of the Texas Register notice and final order approving a name change in its pending docket. On September 27, the administrative law judge's (ALJs) Order No. 2 directed Corix to provide notice of its name change in the *Texas Register*.

**I. COMISSION STAFF'S CLARIFICATION AND REQUEST**

Notice in this proceeding is governed by 16 Tex. Admin. Code (TAC) § 22.55, which states, "the presiding officer may require a party to provide reasonable notice to affected persons."<sup>1</sup> In its Order No. 2, the administrative law judge (ALJ) directed Corix to provide notice in the Texas Register of this name change proceeding. Staff requests the process used in Docket No. 53636<sup>2</sup> be followed in this docket, and that the Commission provide notice of this name change request to the Texas Register for publication.
