To Whom It may Concern:

We are owners of the ranch property crossed by line segment 44 per the Directly Affected Land Owners List. We are opposed to this route or any route that crosses our property.

We have three concerns.

- 1. Our property is used for cattle and wildlife habitat for which it has a wildlife exemption. The property has three stock ponds used to water our cattle and wildlife. The proposed route would cross over a pond that is home to fulvous whistling ducks, turkey, deer, hogs and other wildlife including a rare white crowned pigeon. We have pictures we will submit of the wildlife at this pond. The 150 foot easement required for these transmission lines would have a severally negative impact on the present use this pond for cattle as well as native wildlife, if not destroying it all together.
- 2. The proposed route for these high voltage transmission lines is 300 feet from the house and our water well which we feel could have a detrimental impact on our health and well-being. We already have Karnes Electric Co-Operative transmission lines and easement running through the property which segment 44 will cross. Maps of the property and proposed route will be submitted.
- 3. The proposed route would significantly impact the present use of our property and significantly reduce the value of our property.
