# MOTION TO INTERVENE OF JULIE GAIL MITCHELL MARBLE AS TRUSTEE OF THE JULIE GAIL MITCHELL MARBLE GST TRUST; JANET CORN IVY, INDIVIDUALLY AND AS TRUSTEE OF THE JANET IVY CORN GST TRUST; AND VENETIA MITCHELL

NOW COMES Julie Gail Mitchell Marble as Trustee of The Julie Gail Mitchell Marble GST Trust;<sup>1</sup> Janet Corn Ivy, Individually and as Trustee of The Janet Ivy Corn GST Trust;<sup>2</sup> and Venetia Mitchell (each a "member" of the Mitchell Family Alliance)<sup>3</sup> and, pursuant to P.U.C. Proc. R. 22.101, 22.103, and 22.104 and the applicable Order of Referral and Preliminary Order, timely file this MOTION TO INTERVENE, respectfully showing as follows:

1. Applicant has identified the above-referenced members of the Mitchell Family Alliance as owning property that may be affected by the outcome of this

proceeding, and as such are directly affected landowners and have a justiciable interest in this proceeding. See P.U.C. PROC. R. 22.103(b)(2); P.U.C. PROC. R. 22.52 (a)(3).

- 2. Each above-referenced member of the Mitchell Family Alliance acknowledges that if granted Intervenor status he/she/it (1) will be a party to the case; (2) will be required to respond to all discovery requests from other parties in the case; (3) may cross-examine other witnesses or be cross examined at the hearing if they file direct testimony; (4) will serve every other party in this case, except where service is modified by alternative service procedures set out by order in these proceedings, if they file any document in these proceedings; and (5) are bound by the Procedural Rules of the Texas Public Utility Commission and the State Office of Administrative Hearings.
- 3. Pursuant to PURA § 37.053, the Commission has jurisdiction over this case and each of the above-referenced members of the Mitchell Family Alliance.
- 4. The undesigned attorneys, James K. Spivey and Soledad M. Valenciano, hereby make their notice of appearance in this matter on behalf of each of above-referenced members of the Mitchell Family Alliance.
