### THE MITCHELL FAMILY ALLIANCE'S INITIAL BRIEF

Now comes the MITCHELL FAMILY ALLIANCE<sup>1</sup> and files this, its Initial Brief, respectfully showing as follows:

#### I. INTRODUCTION.

Six "Routes of Interest" have emerged as the focus of these proceedings: Routes M, N, U, Y, N-AB and U-Alt-2.<sup>2</sup> Because the parties' initial briefs will speak for themselves, and because it is anticipated that the initial briefs will reveal a strong preference for and support of the Routes of Interest (to the exclusion of all other alternative routes), the Mitchell Family Alliance's Initial Brief focuses only on confirming its non-opposition to each of the Routes of Interest. It should be noted that each of the Routes of Interest use

Segment 3, which crosses the Mitchell Family Alliance's property.<sup>3</sup> Nevertheless, the Mitchell Family Alliance does not oppose any of the Routes of Interest on this ground or otherwise.<sup>4</sup>

#### CONCLUSION

The Mitchell Family Alliance respectfully requests that the Administrative Law Judges recommend, and the Commission order, one of the Routes of Interest, as each would more favorably comply with PURA § 37.056(c), P.U.C. SUBST. R. 25.101, applicable routing criteria, and Commission precedent, when compared to the remaining alternative routes included in the evidentiary record.
