The Office of Policy and Docket Management (OPDM) has identified the following evidentiary issue that requires a response from the parties.

Please identify the location in the evidentiary record that identifies, using verifiable landmarks, the precise dividing point between CPS Energy's and STEC's ownership and operation of the Howard Road-to-San Miguel transmission line along routes M, N, N-AB, U, and Y discussed in the proposal for decision. It appears that the applicants have identified the precise dividing point to compute the cost estimates in the application. The Commission's practice is to identify the precise dividing point, including identification and ownership of the demarcating structure, in its orders.2

OPDM requests responses to this issue by Wednesday, April 16, 2022 at 3:00 PM. If the requested information is not in the evidentiary record, please file this requested information as well as a motion to admit the additional evidence.
