EXHIBIT "A"
(Howard Road to San Miguel 345KV Transmission Line Project)

We are the owners of ranch property crossed by Line Segments 59, 64, and 65, per the Directly Affected Landowner List. We oppose this route or any route that crosses our property. Reasons for our opposition include the following:

1. The property is used for an active cattle business and hay business, and the route would cross over pastures that use pivot irrigation systems for these businesses, and the route would make it impossible to use two pivot irrigation systems. This would have a severely negative impact on our present use of the land. This cannot be understated.
2. The property contains at least two ponds used for cattle watering and as a source for the irrigation system within the proposed route. The ponds are home to several species of native fish and are seasonally home to ducks and other native animals. The route would have a severely negative impact on our present use of the ponds for cattle, as well as native wildlife.
3. The proposed route is several hundred feet from our home and another habitable structure used by a tenant near a barn. This would cause disruption and devaluation of the property.
4. The property has frontage off of FM 3350, which would be significantly diminished by the proposed route, causing a significant loss of value to the property.

We plan to take all legal action possible to prevent the route from crossing our property at this stage in the process, and in eminent domain proceedings if necessary.
