

To the Public Utility Commission of Texas,

Proposed line segment 95 runs the entire length of our property, essentially splitting it in half and interfering with our current and future development plans. The proposed route runs through the portion of land where we built an 1800 sq. ft. shop/garage steel building that will be connected to our future home. Construction of the transmission line on our property will prevent us from building our home and would disrupt the location of the deer blind we assembled, the food plot we created for the wildlife, and the barn we constructed to provide shelter, water, and food for our cattle. It is also important to mention that the Texas Horned Lizard and the Texas Blue Indigo snake reside on our property. The back portion of our property is undisturbed, providing a habitat for deer and other wildlife, and is in a floodplain. Construction on our property does not make sense when talking about electricity towers and electrical lines in a floodplain zone. The utility's proposed route 95 effectively ends our plans of enjoying and living on our property. Constructing this line along the straightest, most direct route seems more cost-effective.
