JOINT MOTION TO ADMIT EVIDENCE

Entergy Texas, Inc. ("ETI") on behalf of itself, Cities, ¹ Texas Industrial Energy Consumers, and the Staff of the Public Utility Commission of Texas ("Commission Staff") (collectively, "Movants") submit this Joint Motion to Admit Evidence.

Movants request the following evidence be admitted into the record:

- 1. ETI's Application and confidential attachments, including the direct testimonies and exhibits of Chris E. Barrilleaux, Jace R. Carlock, and Kristin Sasser filed on September 20, 2024 (Interchange Items 2-3);
- 2. ETI's proof of notice filed on September 30, 2024 (Interchange Item 6);
- 3. Commission Staff's recommendation on the administrative completeness and sufficiency of notice filed on October 15, 2024 (Interchange Item 11);
- 4. Commission Staff's recommendation on final disposition filed on October 24, 2024 (Interchange Item 15); and
