**ORDER NO. 2**  
**FINDING APPLICATION ADMINISTRATIVELY COMPLETE**  
**AND NOTICE SUFFICIENT AND ENTERING PROCEDURAL SCHEDULE**

This Order addresses the sufficiency of Pedernales Electric Cooperative, Inc.'s September 26, 2024 application for a wholesale transmission service at distribution voltage (WTS-DV) tariff under 16 Texas Administrative Code § 25.191(d)(2)(C).

On October 22, 2024, Commission Staff filed a recommendation on the administrative completeness of the application, notice, and proposed procedural schedule.

The administrative law judge (ALJ) finds the application administratively complete and directs Pedernales Electric to provide notice of the application to any current WTS-DV customers of Pedernales Electric or to any entities requesting WTS-DV service from Pedernales Electric and file proof that such notice, if any, was provided.

The following procedural schedule applies for the continued processing of this application:
