NOTIFICATION OF AGREEMENT TO MODIFY SCHEDULE OTHER THAN THE HEARING DATE

On behalf of all parties to this proceeding, ¹ El Paso Electric Company ("EPE") hereby notifies the Administrative Law Judge that the parties have agreed to a three-week delay of the date for filing of rebuttal and cross-rebuttal testimony. This agreement does not affect the hearing on the merits, which remains scheduled for June 5-6, 2025, pursuant to Order No. 4. However, it does affect the dates for other events between the filing of rebuttal and cross-rebuttal testimony and the hearing. Order No. 4 states that the parties can agree, without further order, to modify any of the dates in the procedural schedule other than the hearing on the merits.
