STAFF 3-3:

- b. Please explain in detail what benefits related to purchased power has EPE received through its purchases in wholesale energy markets?
 - i. How do these benefits compare to the benefits that a reasonably prudent utility would have achieved through its operations within the wholesale energy markets?
- c. Please explain in detail if EPE's are costs associated with its participation in energy and ancillary service markets and properly included in its fuel expense.

EPE prudently participated in whole-sale energy markets during the Reconciliation Period.

c. EPE's costs associated with its participation in ancillary service markets are not included in its fuel expense. The administrative costs incurred by EPE for its participation in the Energy Imbalance Market are prudently included in fuel expense because those fees reimburse CAISO for its optimization of EPE's transactions, which result in significant fuel savings for customers.
