**COMMISSION STAFF'S REQUEST FOR EXTENSION  
FOR THE BENEFIT OF THE APPLICANT**

On October 1, 2024, Concho Rural Water Corporation (Concho Rural) filed an application regarding the September 2023-August 2024 true-up report Concho Rural filed in compliance with its approved Pass-Through Gallonage Charge (PTGC) adjustment provision in its Water Utility Tariff, approved in the final order of Docket No. 49892.<sup>1</sup> The true-up report also implements a PTGC for its Group 1 customers, reflecting a PTGC of \$1.87 per 1,000 gallons. Concho Rural proposes an effective date of November 1, 2024.

On October 22, 2024, the administrative law judge filed Order No. 2, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a final recommendation or to request a hearing by November 19, 2024. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff has conferred with Concho Rural about supplemental notice information. Staff needs additional time to receive the supplemental information and review the materials before Staff can make a final recommendation as required by Order No. 2. Staff respectfully requests an extension of time to December 4, 2024, to respond to Order No. 2.

**II. CONCLUSION**

For the reasons discussed above, Staff respectfully requests the entry of an order extending Staff's deadline to respond to Order No. 2 to December 4, 2024.
