## CITY OF EL PASO'S STATEMENT OF POSITION

The City of El Paso, Intervenor, ("City") files this Statement of Position as required by 16 T.A.C. §22.124. The City's Statement of Position is timely filed.

The City takes the position that the recommendations by Staff of the Public Utility Commission of Texas regarding the secondary cap on performance bonuses for the 2024 program year should be adopted.<sup>1</sup> The City supports Staff's contention that good cause exists to cap performance bonuses for the 2024 program year and the recommendations for the Commission to initiate a rulemaking to amend 16 TAC §§ 25.181 and 25.182 to address future anomalies. The City reserves the right to participate in the hearing and to take positions based on the evidence.
