JOINT REQUEST FOR EXTENSION FOR THE BENEFIT OF THE APPLICANT

On October 15, 2024, Tenaska Power Services Co. (Tenaska Power) filed an application to amend its Option 2 retail electric provider (REP) certificate to add a new REP customer under PURA¹ § 39.352 and 16 Texas Administrative Code (TAC) § 25.107.

On December 20, 2024, the administrative law judge filed Order No. 4, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a clarification by January 15, 2025. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Under 16 TAC § 22.4(b), a party may request that the time allowed for filing any documents be extended for good cause. Tenaska Power has communicated with Staff that it intends to file supplemental information, so Staff needs additional time to receive and review such supplemental information before it can file a clarification. Staff has accordingly conferred with counsel for Tenaska Power about this request, and Tenaska Power has agreed to join the motion. Accordingly, Staff and Tenaska Power jointly request an extension of time until January 31, 2025, for Staff to file its clarification.

II. CONCLUSION

For the reasons discussed above, Staff and Tenaska Power respectfully request the entry of an order extending Staff's deadline to respond to Order No. 4 to January 31, 2025.
