COMMISSION STAFF’S CLARIFICATION IN RESPONSE TO ORDER NO 8

On October 23, 2024, SJWTX, Inc. dba the Texas Water Company (SJWTX) filed an application to amend its water Certificate of Convenience and Necessity (CCN) No. 10692 in Comal County.

On April 23, 2025, the administrative law judge (ALJ) filed Order No. 8, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a clarification regarding a typo in the description of the general location of the property by April 30, 2025. Therefore, this pleading is timely filed.

I. CLARIFICATION

The typo in question was identifying the property as being northeast of the city of New Braunfels, when it is in fact northwest. Staff continues to recommend the notice is sufficiently specific so as to provide reasonable notice to affected parties pursuant to 16 TAC § 22.55. To the extent that the ALJ finds the notice deficient, Staff recommends that SJWTC be excepted from any imputed requirement of a general location description in published notice for good cause shown pursuant to 16 TAC § 22.5(b). Staff therefore respectfully requests an order finding SJWTX’s notice to be sufficient.

II. CONCLUSION

For the reasons detailed above, Staff recommends that the notice, as supplemented, be deemed sufficient and that the proposed procedural schedule be adopted in Staff’s previous filing. Staff respectfully requests the entry of an order consistent with these recommendations
