- Staff 1-4** If Good Charlie intends to use and maintain a letter of credit, please confirm that the information provided in Part C-3 of Good Charlie's Interchange Item No. 12 is correct.
- Staff 1-5** If Good Charlie intends to use and maintain a segregated cash account, please confirm that the information contained in Attachment C-3 to Good Charlie's Interchange Item No. 13 filing is accurate.
