RE: Request to Transition from Submetered to Allocated Billing Utility Service Registration Number: S7006

I am writing to formally request approval to transition Vizcaya Apartments, located at 18108 S Park View Dr, Houston, TX 77084, from submetered billing utility service to allocated billing utility service. This request is submitted in accordance with Commission requirements and pursuant to §24.279 of the Texas Administrative Code.

We are seeking this change due to a failure in the submetering equipment, which has resulted in persistent and ongoing issues. The transmitters installed as part of the submetering system, manufactured by **Next Century**, are no longer reading accurately. After thorough evaluation, it has been determined that replacing all necessary equipment would cost in excess of \$56,000, as quoted by National Utility Services. Due to the high cost, repair or replacement of the current system is not financially feasible.


To date, no costs have been incurred toward repair or replacement. A copy of the vendor's proposal is included in the supporting documentation submitted along with this letter.

We understand and acknowledge the requirements outlined in §24.279 (a), (b), and (c) concerning rental agreements, and will ensure full compliance prior to implementing any change in billing method.
