CONTROL AND IMPROVEMENT DISTRICT NO. 99'S AGREED MOTION TO  
ABATE**

Civitas Cypresswood Owner I, LLC and Harris County Water Control and Improvement District No. 99 (collectively, the "Movants") are attempting to finalize an agreement to settle all issues in this appeal. Therefore, the Movants jointly request that this matter be abated for a period of thirty days from the date this Motion is granted.<sup>1</sup> This will permit the Movants to finalize and memorialize an agreement, and prevent the unnecessary expenditure of fees. The Movants agree to notify the Administrative Law Judge at the conclusion of thirty days whether a settlement has been reached, additional time is needed, or if settlement is not feasible and this matter should be resumed.

**PRAYER**

WHEREFORE, PREMISES CONSIDERED, the Movants respectfully request that the Commission (1) abate this matter for a period of thirty days, (2) enter an order reflecting the same, and (3) grant the Movants any further relief to which they may be justly entitled.
