JOINT PROPOSED PROCEDURAL SCHEDULE

On December 16, 2024, the City of Conroe (Conroe) and Aqua Texas, Inc. (Aqua Texas) (together, Petitioners) filed a petition for approval of a service-area contract under Texas Water Code § 13.248 and to amend Conroe’s certificate of convenience and necessity (CCN) number 10339 and Aqua Texas’s CCN numbers 13203 in Montgomery County. Petitioners filed a revised petition on December 27, 2024, and supplemental information on February 18, 2025.

On March 26, 2025, the administrative law judge (ALJ) filed Order No. 3, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) and Petitioners (collectively, the Parties) to file a proposed procedural schedule by April 2, 20235. Therefore, this pleading is timely filed.

I. PROCEDURAL SCHEDULE

The parties propose the following procedural schedule:

Deadline for intervention	February 10, 2025 ¹
Deadline for Commission Staff to provide final maps, certificates, and tariffs (if applicable) to Petitioners	May 19, 2025
Deadline for Petitioners to file signed consent forms with the Commission	June 2, 2025
If no hearing is requested, deadline for Staff to file a final recommendation on the petition	June 9, 2025
If no hearing is requested, deadline for the parties to file joint proposed findings of fact and conclusions of law	June 16, 2025

¹ Pursuant to 16 TAC § 22.104(b), the deadline to intervene is 45 days after the petition is filed. The revised petition was filed on December 27, 2024, making the 45th day Monday, February 10, 2025.

II. CONCLUSION

The Parties respectfully request the issuance of an order approving the proposed procedural schedule.


