1. Historical five-year reporting period: 01/01/2020-12/31/2024

What percentage of overhead transmission facilities greater than 60 kilovolts did you inspect for compliance with the National Electric Safety Code (NESC) relating to vertical clearance in the historical five-year reporting period?

For the period from 1/1/2020 to 12/31/2024, CPS Energy has used LiDAR in conjunction with PLS-CADD to model and evaluate 100% of CPS Energy's transmission system for compliance with the NESC relating to vertical clearances.


2. Future five-year reporting period: 01/01/2020-12/31/2024

What percentage of overhead transmission facilities greater than 60 kilovolts do you anticipate you will inspect for compliance with the NESC relating to vertical clearance during the future five-year reporting period beginning on January 1 of the year in which this report is submitted?

During the next five-year reporting period beginning January 2025, CPS Energy anticipates having 100% of overhead transmission facilities inspected for compliance with the NESC related to vertical clearance that are greater than 60kV.

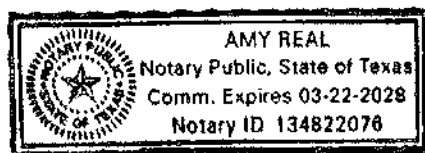
