#### CEHE-IBEW 1-2

With reference to the direct testimony of Mr. Allen, please identify each 500-year flood event of which Mr. Allen is aware that has occurred in CenterPoint Houston's service area since January 1, 2015.

#### Response to CEHE-IBEW 1-2:

Mr. Allen understands a 500-year flood event is based on probability of a 1-in-500 (0.2 percent) chance a flood will occur in an area in any given year. Mr. Allen understands the Houston area saw 500-year floods on Memorial Day weekend in 2015 and another in April 2016. Hurricane Harvey in August 2017 was the third 500-year flood event since January 1, 2015. Mr. Allen experienced a second flood at his residence in 2016 but does not know if that was another 500-year flood event.
