- Staff 1-2** Please provide an electronic copy of Exhibit A.
- Staff 1-3** Please provide by Public Water System Identification Number (PWSID) number and region totals collected and refunded for the system improvement charges (SIC). The presentation should be broken down into same columns or categories in Exhibit A.
- Staff 1-4** Please provide by region and PWSID summary sheets from the billing system showing credits refunded to customers during their billing cycle.
- Staff 1-5** Please provide totals by category (Amended SIC, Interest on Amended SIC, Add'l RAF collected on Amened SIC, and Interest on additional RAF collected on Amended SIC) refunds given for the different billing cycles.
- Staff 1-6** Please explain whether Aqua provided the refunds to customers over one billing cycle. Please specify all the billing cycles possible for the refunds.
