ORDER NO. 2 WITHDRAWING TARIFF AND CLOSING DOCKET

This Order addresses San Bernard Electric Cooperative, Inc.'s February 6, 2025 application to withdraw its most recent wholesale transmission service tariff previously approved in Docket No. 50732.¹

In Docket No. 53738,² the Commission approved the transfer of all of San Bernard's transmission assets to South Texas Electric Cooperative, Inc. To reflect that transfer of transmission assets, the Commission, in Docket No. 56639, set San Bernard's transmission cost of service and wholesale transmission service rates to \$0, effective October 24, 2024. The Commission also acknowledged that, upon the conclusion of Docket No. 56639, San Bernard would seek Commission approval to withdraw its wholesale transmission service tariff.⁴

In light of the actions taken in Docket Nos. 53738 and 56639, San Bernard initiated the present proceeding in order to withdraw its wholesale transmission service tariff. On February 28, 2025, Commission Staff recommended that this application be approved, and that San Bernard's tariff be withdrawn.

The administrative law judge (ALJ) orders that San Bernard's wholesale transmission service tariff is withdrawn and no longer in effect. Accordingly, within 10 days of the date of this Order, Commission Staff must file, in this docket, a request to Central Records to void the tariff
