NOTICE OF APPROVAL

This Notice of Approval addresses the February 18, 2025 application of Tenaska Power Services Co. to amend its option 2 retail electric provider (REP) certificate number 10035. Tenaska Power Services Co. seeks the amendment to reflect the addition of a customer.

Tenaska Power Services Co. is an option 2 REP and is a Nebraska corporation registered with the Texas secretary of state under file number 10633606.

On April 9, 2025, Commission Staff recommended approval of the application.

Tenaska Power Services Co.'s application to amend its REP certificate was submitted on a Commission-approved form containing all of the information required by 16 Texas Administrative Code (TAC) § 25.107(c)(1) and verified by oath and signed by Jeremy Carpenter, vice president of Tenaska Power Services Co.

Under 16 TAC § 25.107(d)(2)(I), an option 2 REP must file a signed, notarized affidavit from each customer with which it has contracted to provide one megawatt or more of energy. Each customer affidavit must state that the customer understands and accepts the REP's ability to provide continuous and reliable electric service based on the applicant's financial, managerial, and technical resources. Tenaska Power Services Co. filed the required signed and notarized affidavit in a confidential filing on February 18, 2025.

Under 16 TAC § 25.107(h), a REP must maintain and update the information required by subsections (d), (e), and (f) of this section, as applicable, on an ongoing basis. Under 16 TAC § 25.107(h)(2), a REP must apply to amend its certification within ten working days from the occurrence of a material change to its certification. A material change includes the addition of customers served by an option 2 REP.

Tenaska Power Services Co. submitted its application on February 18, 2025, and stated the changes were effective on February 1, 2025. Tenaska Power Services Co. has complied with 16 TAC § 25.107(h).

Tenaska Power Services Co.'s application satisfies the requirements of 16 TAC § 25.107. The Commission amends REP certificate number 10035 accordingly.¹
