# ORDER NO. 3 FINDING PETITION, AS SUPPLEMENTED, ADMINISTRATIVELY COMPLETE, FINDING NOTICE SUFFICIENT, AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the sufficiency of the February 25, 2025 petition of Waterstone Land Partners, Ltd. to amend County Line Special Utility District's certificate of convenience and necessity number 21119 in Caldwell County by streamlined expedited release. On March 25 and April 24, 2025, the petitioner filed supplemental information.

### I. Finding Petition, as Amended, Administratively Complete and Notice Sufficient

On May 27, 2025, Commission Staff filed its supplemental recommendation on administrative completeness of the petition, sufficiency of notice, and proposed a procedural schedule.

The administrative law judge (ALJ) finds the petition, as supplemented, administratively complete and notice sufficient. The finding of administrative completeness does not address the merits of the petition.

### II. Establishing Procedural Schedule

Under Texas Water Code (TWC) § 13.2541, the granting of streamlined expedited release initiates an appraisal process to determine the amount of monetary compensation that may be owed by the landowner to the CCN holder for the tract of land that was released. Therefore, an order granting approval for streamlined expedited release is interim in nature and, in the event the requested release is approved, the docket will continue for the purpose of determining the issue of compensation.
