**ORDER NO. 4**  
**REQUIRING REPORT AND RECOMMENDATION**

This Order addresses the compliance filings made in accordance with the Order Appointing a Temporary Manager filed on April 3, 2025, in Docket No. 57818.<sup>1</sup> Ordering Paragraph 7 requires Mark Patterson to report to the Commission on a monthly basis. Specifically, by the last day of each month, the following documentation for the previous month must be filed: an income statement for the reporting period, including the disposition of any assets; a summary of utility activities, such as improvements or major repairs made, number of connections added, and amount of water produced or treated; and any other information required by the Commission. Additionally, Ordering Paragraph 6 required Mr. Patterson to file an inventory, in this docket, of all property received within 60 days of his appointment as temporary manager.

In Order No. 1 filed on May 8, 2025, the administrative law judge (ALJ) ordered Mark Patterson to file the required report for April 2025 by May 15, 2025. To date, Mr. Patterson has not filed a response to Order No. 1.

In Order No. 2 filed on May 16, 2025, the ALJ ordered Mr. Patterson to file the required report for April 2025 by May 23, 2025. To date, Mr. Patterson has not filed a response to Order No. 2.

In Order No. 3 filed on May 28, 2025, the ALJ ordered Mr. Patterson to file the required report for April 2025 by June 2, 2025. To date, Mr. Patterson has not filed a response to Order No. 3.

By June 17, 2025, Mr. Patterson must file all of the required status reports for April and May 2025 and the required inventory, in accordance with Ordering Paragraphs 6 and 7 of the Order in Docket No. 57818.

On or before July 10, 2025, Commission Staff must file a recommendation on the status reports and the inventory to be filed, and whether they comply with Ordering Paragraphs 5 through 7 of the Order in Docket No. 57818. Additionally, Commission Staff must file new recommendations every three months thereafter.
