#### Question No. STAFF 3-3:

Using the parameters of 16 TAC § 25.182(d), please explain in detail, Southwestern Electric Power Company's basis for including Project No. 57172 proceeding expenses in its requested EECRF.

#### Response No. STAFF 3-3:

16 TAC § 25.182(d) authorizes utilities to recover the cost of the immediately preceding EECRF proceeding's expenses. Soon after Commission Staff filed its Petition in Docket No. 57172, SWEPCO incurred expenses to assess the potential impact of the Petition, including on the Company's then-current EECRF proceeding.
