COMMISSION STAFF'S REQUEST FOR HEARING

On May 1, 2024, Southwestern Electric Power Company (SWEPCO) filed an application to adjust its energy-efficiency cost recovery factor (EECRF) and related relief for program year 2026 in accordance with Public Utility Regulatory Act (PURA)¹ § 39.905 and 16 Texas Administrative Code (TAC) §§ 25.181 and § 25.182.

On May 19, 2025, the administrative law judge (ALJ) for the State Office of Administrative Hearings (SOAH) filed SOAH Order No. 3, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) and any other party to either request a hearing by June 12, 2025. Therefore, this pleading is timely filed.

I. REQUEST FOR HEARING

Staff respectfully requests a hearing on the merits and that a hearing be set on the date notated in SOAH Order No. 1.

II. CONCLUSION

For the reasons detailed above, Staff respectfully requests an order consistent with the foregoing.
