




BEFORE ME, the undersigned authority, on this day personally appeared Dee Hooley, who being by me first duly sworn, on oath, deposed and said the following:

1. My name is Dee Hooley. I am employed by Southwestern Public Service Company ("SPS") as Regulatory Administrator. I am authorized to make this affidavit and I have personal knowledge of the facts stated herein.
2. On May 1, 2025, SPS filed with the Public Utility Commission of Texas an application to adjust its Energy Efficiency Cost Recovery Factor ("EECRF"). The application has been assigned Docket No. 58017.
3. SPS served notice of the EECRF filing by electronic mail to the parties to SPS's most recent completed base rate case, Docket No. 54634; to all parties that participated in the case in which SPS's 2024 EECRF was adjusted, Docket No. 56570; and to the state agency that administers the federal weatherization program, which is the Texas Department of Housing and Community Affairs ("TDHCA"). 
