**ORDER NO. 2**  
**FINDING APPLICATION, AS SUPPLEMENTED, ADMINISTRATIVELY COMPLETE,**  
**REQUIRING NOTICE, ESTABLISHING PROCEDURAL SCHEDULE**

This Order addresses the administrative completeness of the May 12, 2025 application of T&W Water Service Company dba Blue Topaz Utilities and Inline Utilities, LLC for approval of the sale, transfer, or merger of facilities and certificate rights in Harris County. On June 2, 2025, T&W Water filed a supplement to the application.

On June 11, 2025, Commission Staff filed a recommendation on the administrative completeness of the application, notice, and proposed a procedural schedule.

The administrative law judge finds the application, as supplemented, administratively complete and sufficient for further review and directs the applicants to provide notice of the application and proof of notice in the manner described in the memorandum of James Harville using the included forms attached to Commission Staff's recommendation.

The following procedural schedule applies for the continued processing of this application:
