The proposed rates will apply to service received after the effective date provided below, unless modified or suspended by the Commission. If the Commission receives a sufficient number of protests, separately or in a combined protest letter, from at least 7,897 ratepayers (10 percent of the utility's customers over whose rates the Commission has original jurisdiction) or from any affected municipality before the 91st day after the proposed effective date, the matter will be set for hearing. To: Public Utility Commission of Texas

I am writing in regards to the proposed rate increase by aqua texas. We have lived in a neighborhood serviced by aqua for about 5 years. As soon as we received our 1st bill, we were shocked at the cost of the water. Since then, the cost continued to rise. The cost is significantly more than my previous residence, where we used considerably more water due to the acreage of the lot. This cost is a hardship for many of the residents that live in our modest neighborhood with small lots, where the bills are routinely over 200\$, some reporting bills in the 300-400\$ range.

In addition, the service provided is subpar. There is a considerable amount of sediment in water. Many residents have installed water filtration systems at great expense. Our next door neighbor's water heater line burst due to being blocked by sediment.

We ask that this request be denied to avoid further financial burden on the residents. Water is a necessity, not a luxury and the cost should not be a cost of a luxury service.
