Subject: Opposition to Proposed Rate Increases by Aqua Texas - Eagle Creek Ranch Subdivision

To Whom It May Concern,

I am writing as a concerned resident of the Eagle Creek Ranch subdivision in Floresville, Texas, regarding the recent notice of proposed rate increases submitted by Aqua Texas. These increases are not only excessive, but they pose a significant financial burden on our community—many of whom are on fixed incomes or already struggling with rising living costs.

The proposed adjustments appear to lack adequate justification based on service quality and infrastructure improvements. In our experience, Aqua Texas has not demonstrated commensurate enhancements to warrant such a substantial rate hike.
