We have residential water service but no sewer service from Aqua. We are serviced by the Fulbrook Subdivision Water Plant (SE-W01, PT-SE1). After reviewing the information provided by Aqua, I protest the proposed rate changes.

Fulbrook is a relatively small development in Texas and the existing single rate is based on a 5/8" meter (the smallest). The existing rate is on the low end of the areas serviced by Aqua. I believe that reflects a relatively small cost to provide water service. The existing rate is a single tier volume for minimum to 999,999,999 gallons of water usage (basically unlimited). The proposal includes rates for 4-tiered volumes that are 135% to 409% higher than the existing rate. I do not believe the proposed rates for our area reflect the relative cost of providing service compared to other areas. It seems the high percentage increases also do not reflect the actual cost increase to provide service to our area.

The proposal from Aqua has the same 4-tiered volume usage rates for all areas serviced by Aqua. That does not seem like a reasonable and fair approach to service rates. It is unreasonable to believe those values reflect the relative proportional cost to provide service to all users. The % increases seem overstated to reflect actual costs to provide service to all areas included.

It is proposed that volumetric charges increase but pass-thru charges are unchanged and system improvement charges are 0. If there are truly justifiable reasons for increased rates it is difficult to understand why these items are unchanged and 0.
