Additional comments on proposed rate changes by Aqua Texas

The purpose of this note is to raise my concern regarding the rate changes proposed by Aqua Texas. When reviewing the cost impacts these changes would bring, I see that my average monthly cost would increase almost 50% above my current bills (based on my last 12 months of usage/bills from Aqua). My 2 highest use months would see over a 70% increase, and if my usage stays the same as last year, I would expect to pay approx. \$800 more than I paid the past 12 months.

I realize cost (and prices) increase over time, but these increases appear excessive and unreasonable. Based on these new rates, there are months where I would expect our water cost to exceed the cost of our electricity - a situation I thought would never happen. Also, the tiered pricing model is overly complex and unfairly punishes homeowners during higher use months.

I hope the PUC thoroughly reviews these proposed increases and works to find more reasonable rate structures for homeowners.
