I am writing to protest the Notice of Proposed Rate Change submitted by Aqua Texas.

The proposed gallonage charge for tier 1 is nearly double the prior year and the rates for tiers 2 - 4 are more than double. The reason given for the request is to recover capital investments that were made to maintain and improve water systems and to reflect inflationary increases in operating costs. Aqua estimates an ANNUAL water revenue increase of nearly 18 Million dollars. I live in the Meadow Woods Subdivision and as a homeowner with a large yard and over 40 years of investing, maintaining and upgrading this property, I can not express my concern over what this increase can mean for me to continue to maintain my investment. I request that Aqua not receive this rate increase without a hearing where they can provide evidence to substantiate this large increase.
