Re: Protest of Proposed Rate increase by AQUA - Docket #58124

To Whom It May Concern,

I am writing to formally protest the proposed rate increase by AQUA, as referenced in Docket #58124.

As a resident of Boling Ranch Estates in Parker County and customer impacted by AQUA's service, I find the request for a rate hike both unacceptable and unjustifiable given the current state of the water service and quality we receive in our neighborhood.

Our water is frequently unsafe for consumption. There have been multiple boil water notices issued in just the past year, signaling a serious and ongoing problem with the reliability and safety of the system. Some of these were due to pipes breaking and emergency repairs done.

The water is often heavily chlorinated to the point that it smells and tastes strongly of chemicals, raising further concerns about its safety and long-term effects.

Due to these persistent issues, many in our community are forced to purchase bottled water for all internal use.

The infrastructure is clearly failing, as seen by the reoccurring breaks in the main pipes and continuing leaks at the storage tanks. Service disruptions are far too common.

It is difficult to justify a rate increase when the basic expectations of clean, safe, and reliable water service are not being met.

Until AQUA can demonstrate significant and sustained improvements in water quality, infrastructure reliability, and customer service, I respectfully urge the Public Utility Commission of Texas to deny this proposed rate increase.
