A comparison of our most recent water bill charges (May 2025) to what the charges would be (for the same water usage) using the new proposed rates results in an increase of approximately ~~300%~~ in total water charges. This is an extreme increase and hard to justify based on inflation, higher costs, etc. This increase will cause hardships for many families and will require extreme adjustments to be made in budgeting, etc.
