I am writing to formally oppose the proposed sewer rate increase by Aqua Texas. As a resident of a newly developed neighborhood that is still under construction, I already pay a flat rate of \$90 per month for just the sewer service—an amount that exceeds what I pay the city of Elmendorf for my water. This flat rate applies regardless of household size or usage, meaning that smaller households like mine are unfairly burdened.

Aqua Texas is a large corporation, and residents like me have found it difficult to work with the company. The proposed increase would place an even greater financial strain on ratepayers. It is neither fair nor reasonable to continue raising rates, particularly in growing communities where infrastructure costs should be offset by increasing customer bases.

I appreciate the work of the Public Utility Commission to ensure fair utility rates for Texas residents and urge regulators to reject this proposed rate increase by Aqua Texas.
