RE: Aqua Texas Request to Increase Charges PUCT Docket No. 58124

Dear Sir/Madam:

This letter, in opposition to the proposed rate change submitted by Aqua Texas, is being submitted in conjunction with, and as part of, my Protest Form. I ask that you please consider the below comments and deny Aqua Texas's request to increase charges.

According to the notice, Aqua Texas has requested rate increases effective July 25, 2025. Aqua Texas is requesting changes and increases to, *inter alia*, the minimum monthly charge and the volumetric charge. Specifically, for my water service, it is requesting an increase in the minimum monthly charge from \$31.00 to \$34.90 each month. With regard to the volumetric charge, Aqua Texas is requesting a change from a flat rate charge of \$3.70 per 1,000 gallons (\$0.0037 per gallon) to a tiered system of charges of \$5.498 per 1,000 gallons for 0 to 5,000 gallons, \$8.247 per 1,000 gallons for 5,001 to 10,000 gallons, \$13.745 per 1,000 gallons for 10,001 to 20,000 gallons, and \$15.120 per 1,000 gallons for over 20,000 gallons. According to Aqua Texas, the monthly minimum charge "generally recovers the cost of system infrastructure" (2025 Rate Notification, p. 1), while the proposed tiered volumetric charge ensures that "customers who use less water pay less per gallon." *Id*.

In addition, Aqua Texas plans to eliminate the Federal Tax Change Credit Rider, a credit which it had been passing along to the customer, because "the estimated savings previously included in the credit will be captured in the calculation of the proposed monthly minimum and gallonage rates." *Id.* This does not make sense; it is unclear how eliminating the customers' credit provides the customers with equivalent savings in the monthly minimum and volumetric charges when both of those charges are increasing greatly.

The rate increases requested by Aqua Texas are unconscionable. Although switching to a tiered volumetric system is acceptable, rewarding customers who use less water, the rate increase from a \$3.70 per 1,000 gallons to \$5.498 per 1,000 gallons (for tier 1 users) is excessive, especially on top of the almost \$4 increase in the minimum monthly charge.

Furthermore, Aqua Texas should not be entitled to any rate increase at all. In my opinion, Aqua Texas has not conducted itself in a responsible manner and has not been a reputable steward of our water resources. During the past few years, our neighborhood has experienced a number of low or no water occurrences. Most (though not all) of these disruptions have been the fault of Aqua Texas or its infrastructure. On many of these occasions, neighbors near the Aqua Texas equipment have reported water leaking/pouring from the equipment and running down the street. Despite the neighbors reporting this to Aqua Texas, this water would continue running for hours or days, even during drought conditions when Aqua Texas imposed mandatory restrictions on water use. And, after each of these service disruptions, we are placed under a mandatory boil water advisory; many of us with certain health conditions then have to purchase bottled water to ensure the safety of our drinking water.

With the number of disruptive occurrences that we have experienced, it does not surprise me that Aqua Texas believes that it needs to increase our rates to cover the costs of its system infrastructure or to pay to purchase water. However, the customers should not have to pay to fix infrastructure that Aqua Texas has not been properly maintaining or to purchase excess water because Aqua Texas has been wasteful and not a wise steward of this natural resource.

Thank you for considering my comments. I ask that the Commission deny the proposed rate increase by Aqua Texas.
